Chief Presiding Judge McDermott and Assistant Presiding Judge Craighead,

In late 2011 I "Noticed" yourselves and the other actors of King County Superior Court of misconduct involving Judge James Doerty and, well, yourself Judge McDermott. This misconduct stemmed from Judge Doerty action at your direction (see attached Public Record from the Renton Police Department page 4 line 23-24), while the record in that case (04-3-00375-3 SEA) has been willfully and deliberately altered as the documents Doerty refer's to as "handed down" do not appear on that case file, I am sure you already know this as you directed his actions. To compound the problem Judge Doerty was properly removed from the case on October 17th, 2011 by Lawyer Karma Zaike, as you know case law states upon filing such declaration "the Judicial Officer is divested of any further authority in the case" or he no longer has "discretion", and exception to this would be if the Judicial Officer was unaware of said "declaration of prejudice" but as page 1 line 19-20 indicate he was aware and proceeded anyway.

Shortly after this hearing on October 17th, 2011 I received a set of responsive documents to a records request made under RCW 42.56 from the Renton Police Department, contained in these documents was a document in native MS Word format which while similar to a letter sent from KCSC Judge Doerty (see attached) only the document was opened and saved into the computer system of the Michael W. Bugni Law Office by paralegal Grace Olsen on the afternoon of October 14th, 2011, I further know from PRA requests to the KCPAO that you Judge McDermott were aware of this and likely directed the dissemination of the document to Bugni/Zaike.

Doerty's actions are without a doubt violations of the Judicial Cannons, Zaike's actions are obviously violations of the RPC's, and your actions are crystal clear as well, but yet to date it appears none of the parties have filed a proper CJC or WSBA complaint (self policing Judiciary? not really). Judge Doerty discusses at length the matter of unlawful practice of law, however the investigatory authority for such act lies SOLELY with the WSBA and a Public Disclosure Request response from the BAR indicates no such complaint was EVER filed or investigated by them concerning myself. Judge Doerty as directed by you exceeding his function, usurped his authority and generally showed little respect for the sanctity of the Court.

Judge Doerty and yourself Judge McDermott even went as far as accessing sealed case files and forwarding these sealed documents to third parties who otherwise would have had to seek a court order to obtain, were the joined parties of that action even afforded the chance to object to the release? no Mr. Haggerty nor Ms. Phasavath were ever informed by KCSC of the release of the GAL report conducted by ex KCSC FCS Worker David Hodges.

As the record indicates Judge Craighead had documents between Rodney Kawakami which were also willfully concealed from the public record, and then there is the matter of my case irregularities like the fact there are Two Judges assigned (Craighead and Doyle) as no change of Judge Order was ever signed by the presiding Judge (you McDermott) and Doerty participated in the assignment of Craighead to my case.

So Ms. Zaike has had possession of this "blackmail" document for some time now, it appears she used this or could have used this as leverage for her client Andrea Jolles in the 2-09-2012 hearing in cause number 02-3-03869 Cavener v. Jolles case. In the unofficial transcript attached above Mr.

Cavener asks Judge Doerty several time about the relationship between himself and Karma Zaike, Doerty offers non responsive commentary and at no time did Doerty or Zaike disclose that Ms. Zaike was in possession of incriminating documents which expose this Judicial Officer and yourself Judge McDermott to misconduct or criminal activities.

Fast forward to June 2013, a man well known to you and the actors of KCSC Douglas Bartholomew petitions Snohomish County District Court Presiding Judge Patricia Lyon for a Civil Anti-Harassment Order naming me, Christopher Hupy, as a restrained party, notwithstanding the total lack of Jurisdiction SCDC has over the matter, Presiding Judge Lyon issues a temporary protection order relying in no small part on a letter Mr. Bartholomew attributes to KCSC and/or KCSC Judge James Doerty (ret) see page 8 and pages 20-21 of the attached 6-14-13 Doug Bartholomew Anti Harassment Order, while this letter share similarities it is not identical in form or content, nor is it on KCSC Letterhead, nor is it signed by any Judicial Officer, but yet Bartholomew makes criminal allegations of my behavior from the content of this document, he (along with Judge Lyon) has successfully used it to trespass on my rights.

How did Doug Bartholomew get this document? How long have you been aware of his possession of this document?

Please provide the following documents-

1. Any and all documents delivered by and means by any KCSC Judge or employee to Douglas Bartholomew starting from August 2011 until today.
2. Any document received by and KCSC Judge or employee from Douglas Bartholomew starting from August 2011 until today
3. Telephone records showing any incoming or outgoing call from any KCSC phone to Douglas Bartholomew
4. If the "Doerty letter" mentioned above was forwarded to persons outside KCSC via electronic means (email or otherwise) please provide the complete email and all persons sent to including all Blind Carbon Copy recipients.
5. A letter from Judge McDermott authenticating the document Bartholomew attributes to KCSC APJ James Doerty as a true and correct copy
6. All communications between Judge Craighead, Judge McDermott and/or any other KCSC Judge and SCDC Presiding Judge Patricia Lyon covering the last 60 days.

I conclude at this time that Mr. Bartholomew is himself attempting to somehow influence the court and/or blackmail (in a similar manner as Karma Zaike successfully has) the court with the introduction of the damaging letter in his petition just as Karma Zaike and/or Michael Bugni has used the letter to benefit herself and her client(s)

It appears Judge "Dick" your actions either directly, by directing others, or failure to train and supervise has harmed me yet again, this time unlike the Jeske matter it will not resolve so quickly, I

promise.

Please produce the above requested documents by Monday July 1st, electronic format and delivery are acceptable and requested with certified copies to follow via USPS or personal courier service.
