25 Statutory Authority as a Superior Court Commissioner

1 under RCW 2.24.050 and signed a Revision Order after
2 KCSC Commissioner, Carlos Y. Vealtegui, denied the
3 Temporary Protection Order in KCSC Cause number 04-3-
4 000375-3 SEA [see Plaintiff Exhibits]

5 4.2 The Defendant Sua Suponte Enjoined the Plaintiff in
6 King County Cause number: 04-3-000375-3 SEA [see
7 Plaintiff Exhibits]

8 4.3 The Defendant had no Subject Matter nor Personam
9 Jurisdiction over the Plaintiff in KCSC Cause Number
10 04-3-00375-3 SEA, based upon Plaintiff was not enjoined
11 in the Case/Action, not Served Notice of a hearing to
12 defend the restraint against him in the Order signed by
13 the defendant, in Plaintiff's exhibit 1 on page 2 at x9
14 and the defendant has no authority to sign an Order of
15 Revision.

17 The defendant Jacqueline L. Jeske, has committed acts that
18 are (a) Arbitrary (b) Capricious (c) Wanton (d) Ultra Vires (e)
19 Malicious (f) Stepping outside the scope of Function as a KCSC
20 Commissioner thereby the defendant forfeited the protection
21 under the umbrella of Absolute Immunity and Qualified Immunity
22 (g) Violated her Oath of Office (h) Violated Article 1 Section 1
23 of the Washington State Constitution failure to protect and
24 maintain the Plaintiffs rights (i) Violation of the Washington
25 State Constitution Due Process clause (j) Usurping Authority

1 and (k) Giving the Plaintiff a "Hobson Choice" (No choice at
2 all).

4 The Plaintiff, Christopher J. Hupy, reserves all Rights to
5 amend this complaint based upon Discovery responses by the
6 Defendants and Discoverable material found to be substantive in
7 prosecuting his cause of action in the above titled Court.
